A)	APPLICANT'S OBLIGATIONS:				
1.	Upon the issuance of the Utility Construction Permit (UCP) the Applicant hereby agree to install an electrical conduit system, including all conduit, concrete equipment foundations, and related civil infrastructure as directed by GRU. The GRU conduit system shall be installed as specified by construction plans designed by GRU.	S			
2.	The Applicant hereby represents and warrants that the GRU conduit system shall be installed in accordance with all applicable City of Gainesville Ordinances and the GRU "Energy Delivery Service Guide" and applicable standards and policies of GRU. GRU will inspect the conduit system installation only after the issuance of the UCP and prior to backfilling of the trench. The Applicant will need to schedule these inspections in advance and in accordance with the "Energy Delivery Service Guide". To the extent that any GRU conduit is not installed in conformance with the UCP and/or applicable requirements, the Applicant will cause the necessary repairs to be made within 30 days or receipt of notice of non-conformance and at no cost to GRU.				
3.	For coordination purposes, the Applicant shall have drafted onto the Civil Engineer's plans the GRU designed electrical conduit system in accordance with the "Energy Delivery Service Guide" at no cost to GRU. The plans or drawings shall clearly indicate the location of all conduits and equipment foundations.
