By signing this form and agreeing to participate in the GRU LEEP program, you hereby release, waive, discharge, and covenant not to sue GRU or the City of Gainesville or its officers and employees from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by Applicant or the property referenced above resulting from participation in the GRU LEEP program.
